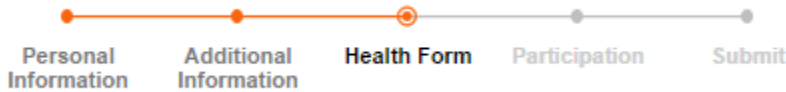

5) **Health Form** information is NOT required at the time of enrollment. However, if your child participates in any County and/or State Events you will be asked to update their records within 4HOnline to have on file. **Click “Continue”**



6) Enter **Participation** Information (Club and Projects) – Youth are **required** to enter at least 1 Club and 1 Project to continue enrollment process. Click “Continue” through Club tab, then Project tab, then Group tab. Groups are designated on a County by County basis. Talk with your county Extension office for guidance on this tab.

All NEW for Family Enrollment – You will be asked a series of Authorization Questions. Electronic Signatures have been approved by Colorado State University Extension 4-H and Colorado State University Legal Services and are legal and binding. – These signatures are required before enrollment in Clubs/Projects. NOTE: The Animal Care and Housing Information is NOT required for all families, only those Youth who will be selecting 4-H animal projects.

Animal Care and Housing Form

ONLY REQUIRED FOR THOSE ENROLLING IN ONE OR MORE ANIMAL PROJECTS (examples below):

Beef Cattle, Dairy Cattle, Goat, Horse, Llama, Poultry, Sheep, Swine, Dog, Rabbit, etc.

It is the responsibility of every 4-H Member to ensure that proper care is taken of their animal(s) according to acceptable methods of good animal husbandry, as set forth by Colorado State University Extension and the Colorado Department of Agriculture. A healthy animal requires sufficient food, water, shelter, and appropriate health care. Cruel and inhumane training methods are prohibited in the Colorado State University Extension 4-H Program and will not be tolerated. Specific animal husbandry guidelines and humane training methods are provided in the appropriate 4-H manual. It is necessary for the local county Extension office to know the location of all 4-H livestock/horse projects.

The Colorado 4-H current project recommendation for primary care states that "4-H members will provide primary and continuous care of their project animals." **Primary care is defined as the 4-H member making the decisions for and/or providing the care, handling, and training of their animal project a majority of the time.** Primary care exemption must be approved by the designated local representative body comprised of at least one Extension agent and other committee representatives as appointed by the Extension office. The county will determine a one-step appeal process if request is denied.

Each situation for exemption of primary care will be evaluated within the exhibitor's county by an appropriate review body. An approval or disapproval of the situation will be communicated to the participant(s) in writing. An appeal may be submitted through established grievance channels established in each county. 4-H members and guardians acknowledge that approval of facilities and animal welfare checks may be conducted at any time by the local county Extension agent.

Submission of the animal care document is required by all 4-H animal project participants each 4-H year. By signing electronically below is your commitment to the above guidelines.

COLORADO 4-H CODE OF CONDUCT

4-H members, leaders, parents, and other adults participating in 4-H activities will:

1. Adhere to program rules, curfews, dress codes, policies, and rules of the facility being used.
2. Conduct themselves in a courteous, respectful manner, use appropriate language, exhibit good sportsmanship, and provide positive role models.
3. Abstain from illegal behaviors, use of alcohol, illegal or illicit drugs, and tobacco during 4-H events and activities.
4. Fully participate in scheduled activities.
5. Respect other's property and privacy rights.
6. Abstain from child abuse (physical and/or verbal) and harassment.
7. Accept personal responsibility for behavior including any financial damage.
8. Be responsible for any financial damage caused by inappropriate behavior.
9. Adhere to rules of safety.

Consequences for violating any part of this code of conduct may include, but are not limited to: removal from participation in the event in which the code of conduct has been violated (at the individual's expense); sanctions on participating in future 4-H events; forfeiture of financial support for the event; removal from offices held, etc.

Behavior outside of 4-H activities can affect "member in good standing" or "volunteer in good standing" status.

It is the responsibility of all program participants to reinforce the code of conduct and intervene when necessary to enforce the rules.
